

Results of interview and additional information received: Sue Manager stated that Jorge Ramirez was no longer an employee at Jack in the Box since April of 2015 and does not know his whereabouts.

I reviewed the city telephone directories for Sacramento, CA and contacted directory assistance on 11/3/2015. I found a 13 listings for Jorge Ramirez in the Sacramento area. I called each. Four were disconnected, the remaining nine numbers were not the Jorge Ramirez I was looking for.

I searched the real and personal property indexes in the Recorder's and Assessor's Offices for Sacramento County on 11/2/2015. I located 23 deeds and 2 judgments. When I looked at the documents, none of them listed only his old address. (consistent with the fact that he is not believed to own a home). The two judgments were his, but

6. I conducted an Internet search on Facebook, Google, LinkedIn on 10/25/2015. I found no new information regarding his whereabouts. I discovered he has a Facebook profile but no employer is listed. Additionally, there were no public updates since February 2015. I sent a message to that account but have so far received no response.

7. I contacted the applicable criminal justice agency (such as California Department of Corrections Locator Service) on 11/3/2015. Jorge Ramirez is not in County Jail or Prison at this time. His whereabouts are unknown.

Other relevant information: On 11/3/15 I drove to Downtown, Sacramento to see if I could find Jorge Ramirez and was unable to locate him anywhere. I also asked at several homeless shelters if they had seen him. Most of the shelters had not, but two of them said they haven't seen him in about three months, when I was there.

Despite my diligent efforts, I have not been able to find Jorge Ramirez.
