

Expungement (Cleaning up a Criminal Record): Understanding Sacramento Court's Expungement Packet

This guide contains samples with instructions for all of the expungement forms included in the Sacramento County Superior Court's [Expungement / Dismissal Information and Petition Packet](https://www.saccourt.ca.gov/criminal/docs/1203-4-dismissal-process.pdf) (<https://www.saccourt.ca.gov/criminal/docs/1203-4-dismissal-process.pdf>) .

This packet also includes the Petition and Order Pursuant to Penal Code 1203.3, 17(b) (Sac Local Form CR-9), which is used to terminate probation early. If you do not need to do this, skip that form.

California Conservation Camp/County Hand Crew (Firefighters) Packet

If you participated in firefighting while incarcerated, either through the Conservation Camp or a county hand crew, you may qualify for dismissal prior to completion of probation, parole, or supervised release.
