The decedent was survived by three children, petitioners Sal Sample, Sara Sample, and Bob Sample. There are no other children alive or deceased.

Decedent and his only spouse divorced in 1979, well before decedent purchased this property. This property was 100% separate property.

Accordingly, the three petitioners are the only successors-in-interest, each entitled to an equal 33.3% share.




