

NEXT STEPS:

2. Record the Reconveyance at the Recorder's Office in the county where the property is located. If you attached the property description (instead of typing it out), be sure to include the attachment when you record the Affidavit.

3. Fees: There are two fees: a filing fee (currently \$20/first page plus \$3/additional page in Sacramento) and a \$75 Building Homes and Jobs Act fee. Current Sacramento fees are available at the <u>Sacramento County Recorder</u>'s website at <u>www.ccr.saccounty.net/Pages/Fees.aspx</u>.

You may qualify for an **exemption from the \$75 Building Homes and Jobs Act fee**. If you do, be sure to claim the exemption on page 1 of your document, or you will be charged regardless.
